MUST have a fire extinguisher on-site. MUST MAKE cancellation requests in writing. **Will order power with CORT separate power application and Payment made to to Cort.** Will set up regardless of weather (this is a rain or shine event).

MILL CREEK CHAMBER OF COMMERCE AGREES TO: DOES NOT SUPPLY ELECTRICITY TO BOOTHS (unless power is ordered on separate application. Does not guarantee exclusivity and booth location. Is not be responsible for damaged property or equipment. Provides security on-site overnight (MCCC does not assume any responsibility for safety of vendor property). Is not responsible for the number of festival visitors and, therefore, not responsible for vendor sales levels. Will not make booth fee refunds after May 1, 2023
